Agenda no 4: Discussion on finalizing vision and Mission of the departments

Discussion: Director IQAC placed the vision and mission framed by all the departments to the IQAC members. The departments who have submitted the vision and mission are:

Prof. Kandarpa Das, Vice chancellor, GCU, told that Vision and Mission are very important for a department and it should be framed carefully and to be screened by committee taking the view of stakeholders . IQAC Director also put his view to complete the process of finalisation of Mission and mMission of the departments such that these can be disseminated at various places.

After a discussion it is resolved that a committee headed by Dr. Robert Ravi, Dean Engg & Tech will initiate the process of finalising the Vision and Mission of the departments / Schools before starting of the next academic and semester.

Agenda no 5: Discussion on Implementation NEP-2020 Syllabus and formulating CO assessment rubrics.

Discussion: Prof Kandarpa Das, Vice Chancellor, GCU informed that the structure of the UG and PG syllabus of GCU has been framed in line of the NEP-2020. Moreover, 1st batch GCU for various programmes started with this framed syllabus. He informed that the UG syllabus pattern started with following Exit Option:

- Certificate for students who completed the 1st year Course with additional 8 weeks vocational training.
 Diploma for students who completed the 2nd year Course with additional 8 weeks vocational training.
 Degree with Major/ Minor who completed the 3rd year Course

- 4. Degree(Hons) with Major/ Minor who completed the 4th year Course

Moreover, student will get option for selecting various Skill Enhancement Courses (SEC), Value Added courses (VAC), Ability Enhancement Courses (AEC) and Multi disciplinary Courses (MDC) in different semesters.

In discussing the formulation of the CO Assessment rubrics Dr. M R Singha, Director, IQAC informed that for the courses conducted at GCU, a uniform formula is required and the NBA Coordination team headed by Dr. Debarshi Mallick may be assigned for framing the CO Rubrics and distributed to the concerned department for implementation.

Decision: Meeting resolved that th IQAC Director will inform NBA Coordination team headed by Dr. Debarshi Mallick for framing the rubrics for CO as well PO Assessment and distribution to the concerned department for implementation. Moreover, the team will also train the newly appointed faculty members to be accustomed with
